EXECUTION OF CONTRACTUAL AMENDMENTS WITH PETROBRAS

Nova Odessa, May 31, 2024 – Lupatech S.A. (B3: **LUPA3**) ("<u>Lupatech</u>" or "<u>Company</u>"), in accordance with CVM Instruction nº 44/2021, announces to its shareholders and the market in general that:

The Company signed amendments to contracts for the supply of: (i) fire-safe ball valves, (ii) ball valves with resilient seals and (iii) ball-type control valves with Petróleo Brasileiro S.A. - Petrobras. These amendments definitively extend for 365 days the contracts listed below, which were due to expire in June 2024, and also increase the volume of supply:
